Brandon is a sixth grader at John Jacob Middle School. Brandon's family has recently fallen on hard times and last week they received a phone call home on a Friday afternoon from one of his teacher's stating that Brandon often seemed distracted and has been unable to finish his work. When Brandon's parents confront him, he has no explanation. The parent's have come to the school today to pick Brandon up and to ask school staff for help with Brandon's sudden change in behavior regarding school.
